Audit Report	The Forest Township Board conducted an audit of Treasurer's and Clerk's 2022 books at the January 2023 meeting. It was determined that the financial data was accurate for the year 2022. The Board unanimously agreed and signed both sets of books. The 2022 Financial Report was submitted January 30th, 2023 to MN State Auditor and was accepted.	
Treasurer Report	 Report on breakdown of expenses and revenue. Reviewed with discussion on fluctuations to expenses/income in trying to maintain balance close to 150% of the budget per recommendation from state. Bank accounts being moved from Citizens National in Park Rapids to Bell Bank in Detroit 	
Public Comment	Lakes. Discussion on interest rates and CD's. Clearing roads: Discussion on early plowing, pushing back/making wider passage, using grader with teeth in past and slush removal in spring. Roads in good shape.

● Town Hall	Tim set off two bug bombs this fall due to terrible insect problem (flies this year). Look into caulking around building. Checking sink for small leak. "Thank you" to John and Karen LaFond for cleaning town hall.	
• Trash/Recycle	Dumpsters: Few violations. Large/heavy items not allowed catching/damaging dumpsters. One door needing fixing will be looked at in spring after snow melt. "Thank you" to Rolf Christiansen for engineering new ways to improve lids and latch's on dumpsters. "Thank you" to volunteers and Township Board for clean up of garbage around town hall/wood area. Discussion on bears in spring and gopher bounty.	
• Roads	Barb presented a handout on 2022 Annual Road Maintenance Costs. Report attached. Roads in good condition. Discussion: Dust control and product called Durablend. Durablend; Environmental factors-oil base, amount of usage – less (every other year), cost -get quote, recommendations/area usage and performance. Estimate for either gravel or dust control and expense increases in budget for 2024. Discussion: Road contracts – good until fall. Road trimming/brushing – talked about on road tour. "Thank you" to everyone helping after storms with downed tree removal. "Thank you" to Barb for trimming/tree removal. Discussion: companies in area that can be hired by property owners for personal tree removal. "Thank you" to Thelen's for very good job maintaining roads.	
Planning Commission	 Lynn reported; Planning Commission have not met as no issues brought forward. Working on clarifying what the application process is by taking items from ordinance and adding guidelines/information to variance application. All shoreline monitored by county. Township monitors conservation area beyond 267'. Discussion: restrictions to businesses in township. Commercial restriction's to conservation area. No new businesses. 	
Weed Report	Lynn met with county – weed inspection meeting. No new weed concerns in area. Mowing and spraying of township road ditches – mostly deal with Spotted Knapweed and Tansy. Notify Lynn if those weeds spotted on township roads. County takes care of 129 and DNR takes care of fire roads.

- AIS motion from 2022 Annual meeting read. Township received no bill in 2022 from BMLAA. Discussion/clarification on separate billing would come from BMLAA to Forest Township for 2022 contribution match. BMLAA received 2022 billing from county December of 2022 and will submit bill to Forest Township to be paid in 2023. Budgeted amount of up to \$2,000 in 2023 would be payable in 2024.
- **Motion by Monette** Lundquist to recommend the following motion to the Township Board: If AIS inspection hours expended for Bad Medicine Lake should exceed the Becker County budgeted amount during 2024 inspection period, Forest Township will match the amount contributed by the Bad Medicine Lake Area Association to cover the excess with the total amount contributed by Forest Township not to exceed a maximum of \$2,500. Upcoming projects: Dust Control? Discussing the option of applying a new dust control product (Durablend) on the south end of East Bad Medicine Road. At this time, the town board does not have a cost for this product.

Minimum maintenance road signs were installed on all township minimum maintenance roads this summer.

There has been some discussion of the amount of work that the township does on minimum maintenance roads before requiring that the road be brought up to a Class C road. The town board reserves the right to require residents to upgrade the road if they want more services.
